Summer 2024 saw the arrival of [The Awarding Map](#), a route map designed to make visible various intersecting factors that contribute to awarding gaps across the learner journey and provide practical tools, insights and approaches that can be used to enact positive change for the most affected student groups.

We also convened two [sector roundtables](#) focused on how institutional data can help us to understand the origins and emergence of awarding gaps, and how we can use evidence to develop and evaluate meaningful actions to achieve equity of experience and award.

In 2024-25, our work on awarding gaps continues as part of a focus on [student outcomes](#) and supporting the tertiary and higher education sectors to meet and go beyond baseline regulatory requirements. This includes [new resources, events and sector insights](#) designed to support staff in a wide range of roles, including senior academic managers, academic practitioners, educational developers, quality professionals and professional services staff, as well as students and those who represent them.

QAA is committed to student engagement and partnership working, through our [governance arrangements](#) and as evidenced by the Principles in the [UK Quality Code for Higher Education 2024](#) and the important role that students play in all of our advisory groups and activities. In 2024-25, students will be involved in all the writing groups producing Advice and Guidance for the revised Quality Code, not least Principle 2 - Engaging students as partners, and on groups informing our work on academic integrity, Subject Benchmark Statements and Characteristics Statements (to name a few).

We also run a large number of [Collaborative Enhancement Projects](#) related to the student experience including projects aimed at improving student retention and attainment,

student representation and student voice, inclusive and effective student engagement, and considering how student engagement and programme delivery can be enhanced with collaborative partners.

In 2024-25, our work on student engagement, representation and partnership working continues and includes **new resources, alongside our regular events, sector networks and committees**. All of which are designed to support students and staff in a range of roles, including students, student representatives and sabbatical officers, students' union/association staff, student engagement staff, programme leaders, academic practitioners and senior academic managers. Trends in Learning, Teaching and Assessment

From evaluating the [impact of block delivery](#) to [embedding inclusive assessment](#), to approaching [Generative Artificial Intelligence](#), we are continuing to develop our suite of resources focused on innovative practices in learning, teaching and assessment.

Inclusivity and compassion are key concerns for sector colleagues. Building on a completed Collaborative Enhancement Project (CEP) - [Belonging through assessment: Pipelines of compassion](#), our new CEP led by University of Bedfordshire, enables you to join and engage with a Compassionate Assessment Network. Find out how you can get involved.

We have been supporting work on **competence-based education (CBE)** with dedicated [sector-wide resources](#) and funding the University of Hull's CEP - exploring the impact of implementing a [Competence-based Framework](#) across a range of higher education providers. We continue to drive work in this area with a CEP specifically targeting [assessment within CBE](#).

Generative Artificial Intelligence (Gen AI) continues to be a focal point for lively debates across the sector, and so, this year, we are [funding six CEPs](#) exploring the opportunities that Gen AI offers. We are also developing guidance that supports providers who wish to reframe their regulations and policies to help students confidently use assistive technologies without breaching academic integrity rules.

Our work on assessment will also seek to open conversations on the role of skills and competencies through QAA-hosted debates. Finally, we will also be supporting the development of the new Integrated Programmatic Assessment Network UK (IPAN UK), which emerged from our [Assessment Festival](#) in April 2024.
